ARE YOU HAPPY?

A recent Reark Research survey of about 300 households in the CAD and Southbank areas revealed that more than 90% were happy with their city lifestyle and more than 80% would recommend it to prospective residents. It was interesting to note that "a wider range of age groups and more owner-occupiers were attracted to the CBD while a comparatively younger group and more renters were moving to Southbank". In the CBD 53% were owner-occupiers and at Southbank only 30% were owner-occupiers.

over fifty years in this, Australia's largest public lending collection. Several huge catalogues display a wide range of subjects: the best of modern films, classics, foreign languages, children's interests, films captioned for the deaf, documentaries, study, school, business and promotional works, etc.

There are various ways of obtaining videos, from browsing in the display area and making an on-the-spot decision to booking up to a year in advance by phone, fax or mail. In the near future, the library will be providing a CD-Rom loan service of educational and cultural titles.

The film library is partly funded by the Victorian government and by some self-funding. Joining fee is

\$70.00 per year (\$50.00 concession) for up to four videos a week. At the next few meetings you will be able to peruse copies of the catalogues. If members are interested, we can arrange for a group to have a browse on the late opening night.

Melbourne Arcades & Laneways

elbourne's city blocks are amongst the largest in the world, and are certainly bigg than those of New York. Each block is interlaced with small arcades and laneways. Thes nes were originally intended to serve the tables and out-office of buildings which fronted the main However, people soon began to build on the lanes thus creating the need for further These arcades and laneways. laneways provide a wonderful opportunity for people wishing to throroughly explore Melbourne.

Today's arcades and laneways offer variety of retail stores. restaurants and small businesses unparalleled in other Australian Amongst the many specialty shops you will find cafes, antiques, recycled clothing, the fashions, books jewellery. Two examples of the more unique shops are Tafts which is Melbourne's only fountain pen specialist and a shop in the Centreway Arcade which stocks books in 29 languages.

The area bounded by Swanston, Elizabeth, Bourke and Flinders Streets contains a maze of arcades connecting with smaller streets and laneways. Many of these lanes retain their nineteenth century character much in keeping with a lot of the buildings and building facades which have been renovated

or restored to their former glory thereby helping to maintain the character and streetscape of the city. The Block Arcade, Howey Place, Royal Arcade and McKillop Street are excellent examples of early Melbourne architecture.

For anyone interested in viewing an old and relatively untouched industrial area of Melbourne, Heape Court and Guilford Lane are fine examples of late 19th entury and early 20th century red brick warehouses built hard onto the stone lanes. Some of these buildings are still used for industrial purposes while others provide studio residences and apartments for those who enjoy city living

CITY LIVING MADE EASY

any people find that city living any people in to combine enables them to combine convenience and efficiency of lifestyle with the very best of leisure and entertainment facilities. streamlined approach to city living can, however, only be arrived at over a period of time. With the busy lifestyle that we lead, it can often be difficult to find the time to seek out relevant information relating to services and facilities that we require. As a result, we remain unaware of all that our city has to provide. Luckily someone has been working behind the scenes to produce a couple of very informative and time-saving guides to city and community services. The first of these is a book titled "The Directory of City of Melbourne and Community Services The Directory lists phone numbers for all of the services

provided throughout the City of Melbourne; including information on noise pollution, busking permits, ethnic services, community health centres, faulty fountains and street cleaning.

I cannot recommend it too highly. The directory is available free of charge, over the counter, at the Melbourne Town Hall in Swanston Walk.

The second guide I wish to recommend is the "RACV Guide to Major Carparks in Melbourne". This truly is a little gem of a brochure. It lists the location, hours of operation, fees, facilities and Melbourne's to undercover CAD carparks; combining a map of the city area that is number coded to correspond with an easy-find graph and a star rating guide to defining features of each carpark. City Parking

When it comes to parking there are two schools of thought.

- a) A desire to be able to park your car for a few minutes without having to put it into your parking space especially if that space is difficult to get at, but the risk of a ticket in those few minutes you are in a Loading Zone, is very high.
- b) The lack of parking facilities at all for some dwellings. Having purchased or rented cheaper accommodation because no park is provided, should this facility be provided free by the Council or community!
- c) Our visitors cannot park in the street when they come to see us. Mind you, the same applies if we live near VFL Park or most other places of commerce or entertainment.

But none of these situations stop us from complaining about the cost, inconvenience or embarrassment which the lack of parking in the street near our home generates.

On the other hand, there is strong feeling of discontent and frustration towards people who park their cars illegally and cause great inconvenience by:

- a) parking in front of or opposite our drive or doorway particularly in lanes - so blocking our access.
- b) blatantly invading our private parking space.

and it is the first of these which I address.

People who come to the city are encouraged by the traders as adding life (business) to the City. They could park in commercial parks, however most very mean with their money and to park free or cheaply on the street

BUT THE. WHAT OF CRIMINALS? - those who pai illegally in "No Standing" areas, loading zones, in doorways and so close to corners they restrict or deny access to lanes in particular. These are things the law says are illegal so the perpetrators are criminals. They may be seen as victimless crimes but are they? Are you not a victim when you cannot gain access to your property due to a criminal act?

So who fights the war against these criminals and at what cost?

The war is fought by our allies, the Grey Ghosts at the cost of their time, wages and expenses, offset against the benefit of the revenue they generate from criminals by way of fines. Any surplus they generate is in reality indirect compensation to the ratepayers for the inconvenience that has been caused by a delivery truck not being able to use a Loading Zone or an owner not

being able to access his property.

during special events, on Sundays around churches and under cover or darkness, especially on Friday and Saturday nights. The major problem we have is that the times of their proliferation coincide with the times of least a juity by our crime fighters.

Everyone knows the strongest rostering of the Grey Ghosts is in the normal 9 to 5 weekdays timeframe - j ified by saying (a) this keeps commerce moving - (b) it saves on penalty rates and (c) the Grey Ghosts do not like working out of hours anyway, especially if they have to give out tickets in dark alleys.

THE END RESULT IS WE HAVE A LOT OF CRIME WHICH AFFECTS US RESIDENTS AND WHICH GOES UNPUNISHED AND WHICH COSTS RATEPAYERS BY WAY OF UNCOLLECTED FINES.

If anyone has tried to obtain the services of a Parking Inspector out of normal working hours they will know how thinly spread the service is and it is reasonable to assume that if there are

THIS IS AN EXCELLENT OPPORTUNITY **PRIVATIZATION** THE OF SERVICE IF ONLY THE AFTER HOURS SECTOR.

My proposal is that I take up a contract to issue Infringement Notices after hours. The notices would be cost free to the Council. the arrangement being that the Council pay me 50% of the total revenue. We the ratepayers would benefit through reduced crime (parking infringements) and increased Council revenue which may just happen to reduce our rates, whilst existing employees would continue the work they are doing now.

The question I would put to Residents 3000 is whether there is any major objection to such a proposal? The biggest drawback of course is that having thought up the idea the rights will probably go to some other party who will gain the main benefit so maybe I should offer Residents 3000 Inc. 5% of the revenue if, through their support, the scheme is introduced.

The Future of the City of Melbourne

The 1990's are proving to be a very interesting period for the City of Melbourne. The Local Government Board has legislated the introduction of Compulsory Competitive Tendering (CCT). This requires that all Councils have to tender a percentage of their annual budget and the targets for the first 3 years have been set at 20, 30 and 50 percent respectively.

Another major change is that privately registered Building Surveyors can issue Building Permits and carry out inspections. coupled together with CCT the whole function of Melbourne's Building Departments could be tendered out to the private sector.

We may see the day when the City of Melbourne will consist of a core staff to oversee a host of private contractors supplying goods and services to us as ratepayers. This is a worst case scenario for staff, but if they

cannot lift their productivity to match the private sector they will become redundant. We as ratepayers will in the future, benefit from these changes by getting value for our rates that we pay to our city
